Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's WebSite [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Bidders, submitting their bid electronically, should deposit the cost(as specified above) of bidding document in the office's account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. Documents received after this deadline shall not be accepted.

6. In the case of discrepancies or error in bid documents, bid notice or any other documents, Shivasatakshi Municipality reserves the right to amend and correct at any time. The figure for the bid amount must be clear if any discrepancy may occur then the figure written in word is valid.

Bids shall be opened in the presence of Bidders' representatives, who choose to attend at 2:00 PM on **November 15, 2018** of Notice Published in Shivasatakshi Municipality, Bids must be valid for a period of **90 days** counting from the day of bid opening and must be accompanied by bid security amounting as stated above deposited at (**dharauli account No. 2210303007102 on behalf of** of Shivasatakshi Municipality at Rastriya Banijya Bank Limited, Bhadrapur, Jhapa or bid bond

authorized from a recognized A class commercial bank of Nepal, which shall be *valid for minimum 120 days* .

8. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.

9. Bids should comply in all respects with the Instruction to Bidder included in the Bid Document. Non Compliance with this instruction shall result in disqualification.

10. Shivasatakshi Municipality reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.

12.1 Average Annual Turnover of the construction work of best 3 years over the last 5 years is: **NRs. 45,07,000.00** (including VAT)

12.2 Minimum work experience of similar nature as Prime contractor, management contractor, or subcontractor, in: at least two contracts within last 5 years, each a value of **NRs. 30,00,000.00** (including VAT) that have been successfully or are substantially completed.

12.3 Bidder's should have construction experiences in key activities of at least 20 cum asphalt pavement works in road construction.
